Los Angeles County Curfew Order

A curfew, as specified below, has been imposed to preserve the public order and safety in the County. (59)

- 1) A curfew, from 6:00 p.m. to 6:00 a.m. is imposed in any "Evacuation Order Zone" or any "Evacuation Warning Zone" within the City of Los Angeles, the City of Santa Monica, the City of Malibu, and all unincorporated areas of the County of Los Angeles, as such zones are identified at any of the following websites: https://lacounty.gov/emergency/; protect.genasys.com; and/or www.watchduty.org. These websites show maps of each Evacuation Order Zone and each Evacuation Warning Zone. Evacuation Order Zones are highlighted on the map in red. Evacuation Warning Zones are highlighted on the map in yellow. (59)
- 2) The hours of curfew are between 6:00 p.m. and 6:00 a.m. until this Order is lifted. (59)
- 3) No person, except as set forth in paragraph No. 4 below, shall be upon a public street, avenue, boulevard, place, walkway, alley, park, or other public area, or any unimproved private property, within the areas described in paragraph No. 1 above, between 6:00 p.m. and 6:00 a.m. (59)
- 4) This Order shall not apply to peace officers; fire fighters; National Guard or other military personnel deployed to the area; emergency medical services personnel; individuals working on a project involving a public work of improvement; credentialed media representatives involved in news gathering; and individuals seeking medical treatment. For residents living within an Evacuation Warning Zone, this Order shall not apply to those residents who are traveling to or from their places of residence. (59)
- 5) To extent that the terms of the County's curfew order are more stringent than any city's curfew order, the County's more stringent terms shall apply within such city to that extent. (59)
- 6) Any violation of this Order is a misdemeanor, punishable by a fine not to exceed \$1,000 or by imprisonment for a period not to exceed six months, or both, as provided by LACC section 2.68.320 or any applicable state or municipal law. (59)
- 7) This Order shall be effective immediately as of January 9, 2025, commencing at 6:00 p.m., and extending until 6:00 a.m. on the date this order is lifted. The County may renew, amend, or extend this Order in accordance with Government Code section 8634 and LACC section 2.68.150. (59)

AT&T is deploying and refueling generators to provide service continuity to our customers until commercial power is restored. (35)
	FirstNet Response Operations Group™ is working around the clock to support public safety's emergency communications and has liaisons engaged with local and federal agencies. (35)
	AT&T is waiving overage charges for Postpaid & Prepaid customers to provide unlimited talk, text and data through February 6, 2025 and waving various charges for residential and business wireline orders placed through January 7, 2026. (35)

T-Mobile	T-Mobile has restored roughly half of the sites that were impacted by commercial power loss. As conditions safely allow, our teams are evaluating impacted sites in Altadena, Duarte,

Calabasas, Malibu, Fillmore and Agoura Hills, and continuing to deploy and refuel portable generators to sites until commercial power is restored. (34)

Thursday T-Mobile and Starlink opened up T-Mobile Starlink Direct-to-Cellular service over impacted areas of Southern California to deliver wireless emergency alerts and SMS and enable 911 texting. While SpaceX's direct-to-cell constellation has not been fully deployed, we are once again temporarily making this early test version available. (34)

T-Mobile teams are on the ground in local communities offering free Wi-Fi connectivity and device charging 24/7 at the T-Mobile Freemont & Huntington retail store: 1318 Huntington Dr., South Pasadena, CA 91030. (34)

T-Mobile is offering unlimited talk, text and data for T-Mobile, Metro by T-Mobile and Assurance Wireless customers in Altadena, La Cañada Flintridge, Los Angeles, Palisades, Pasadena and Sierra Madre who do not currently have this as part of their service plan through Wednesday January 15. (34)

Mint and Ultra Mobile are supporting impacted customers in Altadena, La Cañada Flintridge, Los Angeles, Palisades, Pasadena and Sierra Madre. Mint Mobile: Customers on 5GB, 15GB and 20GB plans will have their high-speed data allotment increased to 50GB through their current billing cycle, all of which can be used as hotspot. Customers on Mint's Unlimited plan will have their high-speed allotment increased to 2TB with no restrictions on hotspot. Ultra Mobile: Customers on plans with a data allotment will have their high-speed data allotment increased to 50GB through their current billing cycle, all of which can be used as hotspot. Customers on Ultra's Unlimited or Unlimited+ plans will have their hotspot allotment increased to 2TB through their current billing cycle. (34)



Energy - Fuel (Gasoline)

Refineries & Major Fuel Pipelines

The question came up on regarding the wildfires in relation to the Southern California Refineries. It is important to note that fuel refined in the LA basin supports Southern California and parts of southern Nevada and western Arizona. There are no inbound pipelines for refined fuel into the region.

Energy - Natural Gas

SoCalGas

Working to resume natural gas service to approximately 5,000 homes in the Malibu community that were not directly affected by the fires. Although long-term repairs will likely be needed in the Pacific Palisades community, SoCalGas is exploring temporary service options for those customers outside the evacuation zone whose natural gas service was interrupted by the fire. We estimate the entire restoration process could take as few as 11 days or as long as 3-4 weeks for all 5,000 customers to be restored. We are seeking mutual assistance from other utilities to bring in additional technicians in an effort to accelerate the restoration process. (36)

Restoring services to customers is a multi-step process. Step 1: Safely Secure Infrastructure - SoCalGas Crews must isolate the supply line and individually shut off the gas meter for the 5,000 impacted customers currently experiencing outages before restoration can begin. This process could take at least 3-4 days. Step 2: Assess and Repair - Once crews finish meter shut offs, SoCalGas technicians must conduct a leak survey. It will take at least 1-2 days to survey approximately 100 miles of pipeline before the area can be re-pressurized. Step 3: Restore - SoCalGas technicians can begin the process of restarting natural gas service to individual residences after the area is re-pressurized. This process could take 2-3 weeks for all impacted homes. (36)

- Individual customers will need to be home or allow access during this process to allow SoCalGas to perform an in-home safety check. Each residence could take 1-2 hours to restore, depending on the type and number of appliances in the home. (36)
- For safety reasons, customers should not attempt to restore gas service themselves.
 Only SoCalGas technicians and certified contractors are authorized to operate the natural gas service shut-off valve. (36)

Water

CalWater	We are aware of a news report being broadcasted that directs all residents of LA County to boil their water for drinking and cooking due to the devastating wildfires currently ravaging the Los Angeles area. This report is incorrect. California Water Service customers are NOT under a boil water order. You do not need to boil your water. The fires and subsequent water used for firefighting are not around our service areas. ⁽⁴¹⁾ Additional Links: CalWater Alert Center
City of Arcadia	The water remains safe to drink for City of Arcadia water customers. The City of Arcadia's water system is independent and not experiencing the quality and demand challenges other systems are facing. (52)
Crescenta Valley Water District	Water is safe to consume at this time. Please use water for essential use only to preserve water supply and pressure for firefighting efforts. ⁽⁸⁾
Kinneloa Irrigation District	Unsafe Water Alert: Due to the Eaton Fire, some structures in the Kinneloa Irrigation District were destroyed by the fire, and some areas in the water system lost pressure. These conditions may have caused harmful contaminants, including benzene and other volatile organic chemicals (VOCs), to enter the water system. As a precaution, the State Water Resources Control Board, Los Angeles County Health Department, and the Kinneloa Irrigation District are advising residents of the affected area to not use the tap water for drinking and cooking until further notice. Due to VOCs ability to vaporize at lower temperatures and become airborne, residents are advised to: Limit use of hot water; Limit shower time/bathing, and do not take baths (use lukewarm water and ventilate area); Use a dishwasher to wash dishes and use air dry setting; Wash clothing in cold water; Avoid using clothes dryers (dry laundry outdoors); Do not use hot tubs or swimming pools; Do not use ice from automatic ice makers; Use proper ventilation when using water indoors. Bottled water should be used for all drinking (including baby formula and juice), brushing teeth, and making ice and food preparation until further notice. Do Not Try to Treat the Water Yourself: Boiling, freezing, filtering, adding chlorine or other disinfectants, or letting water stand will not make the water safe.
Las Flores Water Company	Unsafe Water Alert: Do Not Use Your Water: An unknown substance has been added to the drinking water supplied by The Las Flores Water Company due to a recent Eaton Fire at Two storage tanks; at the Lake Avenue Reservoir site. The State Division of Drinking Water, Los Angeles County Department Public Health, and Las Flores Water Company are advising residents of Altadena to not use the tap water for drinking, cooking, hand washing, or bathing until further notice. It is unknown at this time when we expect to resolve the problem. ⁽⁹⁾
	Bottled water should be used for all drinking (including baby formula and juice), brushing

teeth, washing dishes, making ice, food preparation and bathing until further notice. Boiling, freezing, filtering, adding chlorine or other disinfectants, or letting water stand will not make the water safe. (9)

Do Not Use Notice: Due to the recent fires, Lincoln Avenue Water Company in coordination with State Water Resources Control Board/Division of Drinking Water are advising residents not use the tap water until further notice. What you need to do: 1. Do not use your tap water. Use bottled water for drinking, brushing teeth, bathing, washing hands, washing dishes, making ice and food preparation (including preparation of baby formula and juice). 2. Do not try and treat the water yourself. Boiling, filtering (including installed home water treatment devices), letting water stand or adding chlorine will not make the water safe. Failure to follow this advisory could result in illness. LAWC will notify residents as soon as it is determined that the water is safe to drink.⁽¹¹⁾

Los Angeles Department of Power & Water

Boil Water Notice: The Los Angeles Department of Water & Power (LADWP) and State Water Resources Control Board Division of Drinking Water strongly advise consumers in the 90272 zip code, and adjacent communities in the LADWP service area north of San Vicente Blvd. to only use boiled tap water or bottled water for drinking and cooking purposes until further notice due to low water pressure in the water distribution system stemming from high water usage to respond to the Pacific Palisades wildfire. Bring all tap water to a boil, let it boil for one (1) minute, and let it cool before use. This also applies to water that is used for brushing teeth, making ice cubes, and food preparation such as washing produce. LADWP is issuing this notice as of January 8, 2025. Until adequate water pressure can be reestablished, and water is tested and confirmed to be safe, this notice is in effect. It is possible that disease-causing organisms could be present. LADWP will inform you when tests show that water is safe to drink, and you no longer need to boil your water. This will take a minimum of 48-hrs to complete the testing process in accordance with public safety protocols. (12)

Los Angeles Department of Public Works District 29, Malibu

Boil Water Notice: The Los Angeles County Waterworks District No. 29 (LACWD) recently experienced a low-pressure event due to the Palisades Fire. The State Water Resources Control Board - Division of Drinking Water and LACWD are advising all its customers to only use boiled tap water or bottled water for drinking and cooking purposes as a safety precaution to avoid stomach or intestinal illness. 

Pasadena Water & Power

Do Not Drink Water Notice: The Eaton Fire caused damage to several City of Pasadena reservoirs and pump stations, potentially impacting water quality within the areas shown in gray on the map. While the extent of the damages cannot be evaluated at this time due to the ongoing fire situation and limited accessibility, the water systems that serve the impacted areas may be compromised, including potential debris and other matter from fire damage. Therefore, the City issued a do-not-drink water notification alert, Tuesday, Jan 8, 2025, to notify and protect the health of our community. (7)

Bottled water should be used for all drinking (including baby formula and juice), brushing teeth, washing dishes, making ice and food preparation until further notice. This also applies to pets and domestic animals. Additionally, do not try to treat the water yourself. Boiling, freezing, filtering, adding chlorine or other disinfectants, or letting water stand will not make the water safe to drink.⁽⁷⁾

Active Flanking, Backing & Short-range Spotting. The fire continues to burn with a rapid rate of spread through the mountain canyons and further north into the forest. Flanking fire continues to move outward from the perimeter and larger fuels continue to burn interior.⁽⁵¹⁾

24 Hours: Fire behavior will remain active due to critically dry fuels. As winds calm, fire behavior will moderate. Larger fuels will continue to burn and present containment issues with continued potential for short range spotting and a topography driven fire.⁽⁵¹⁾

48 Hours: As winds calm, fire behavior will moderate. Larger fuels will continue to burn and present containment issues with continued potential for short range spotting and a topography driven fire. (51)

72 Hours: Large fuels will continue to smolder in place with potential for roll out to threaten containment lines. Potential future wind events will play a large role in determining the future fire behavior. (51)






Satellite Fire Activity Map








